ORDINANCE NO. 433

AN ORDINANCE OF THE CITY OF DOS PALOS AMENDING TITLE 17, CHAPTER 60, SECTION 070 OF THE CITY OF DOS PALOS MUNICIPAL CODE

RECITALS

WHEREAS, Section 070 of Chapter 60 of Title 17 of the Municipal Code (entitled "Off-sale and on-sale of alcohol" and hereinafter referred to as "Section 070") governs licenses within the City for the off-sale and on-sale of alcohol at business establishments within the City; and

WHEREAS, Section 070 currently allows for the distribution of business license that contains the off-sale or on-sale of alcohol within the City based on certain license types of the California's Department of Alcohol Beverage Control ("ABC"), including Type 20 (sale of beer and wine for consumption off the package store premises where sold), Type 21 (sale of beer, wine, and distilled spirits for consumption off the package store premises where sold), Type 41 (the sale of beer and wine for consumption on the restaurant premises where sold), and Types 47 and 48 (sale of beer, wine, and distilled spirits for consumption on the restaurant, bar, or night club premises where sold); and

WHEREAS, based on the provisions of Section 070, the City currently has three existing business licenses out of the five allowed for Type 20, four existing business licenses out of the five allowed for Type 21, five existing business licenses out of the five allowed for Type 41, and two existing business licenses out of the two allowed for Type 47 or Type 48; and

WHEREAS, the ABC Type 75 license (Brewpub-Restaurant) authorizes the sale of beer, wine, and distilled spirits for consumption on a bona fide eating place plus a limited amount of brewing of beer, and Section 070 does not currently allow for such a

premises, which would contribute to the economic vitality of the City.

WHEREAS, there are currently business license holders for the on-sale and offsale of alcohol within the City that do not have active business establishments, and thus the licenses are not being utilized as intended for the purpose of serving the City's citizens and contributing to the City's economic vitality; and

WHEREAS, the City currently does not have a system for the processing of applications for business license that contains the off-sale or on-sale of alcohol, including the establishment of a priority for such applicants to obtain an alcohol license when one becomes available; and

WHEREAS, the City Council desires through the passage of this Ordinance to amend Section 070 in its entirety, so as to provide the framework for the application, distribution, and maintenance of business licenses that contain the off-sale or on-sale of alcohol at business establishments within the City.

NOW, THEREFORE, the City Council for the City of Dos Palos hereby ordains as follows:

SECTION 1. FINDINGS

The City Council has duly considered the full record before it, which may include but is not limited to such things as the staff report, testimony by staff and the public, and other materials and evidence submitted or provided to the City Council. Furthermore, the recitals set forth above are found to be true and correct and are incorporated herein by reference.

SECTION 2. PURPOSE

The purpose of this Ordinance to Ordinance to amend Section 070 of Chapter 60

of Title 17 of the Municipal Code in its entirety, so as to provide the framework for the application, distribution, and maintenance of business licenses that contain the off-sale or on-sale of alcohol at business establishments within the City.

<u>SECTION 3</u>. AMENDMENT TO MUNICIPAL CODE

Section 070 of Chapter 60 of Title 17 of the Municipal Code is hereby amended to read as follows:

17.60.070 Off-sale and on-sale of alcohol.

- A. The conditions set forth in this chapter and section shall apply in all districts or zones.
- B. No business license within the City that contains the off-sale or on-sale of alcohol shall be issued or maintained without a demonstration to the City's satisfaction that an appropriate license type from the State of California's Department of Alcohol Beverage Control ("ABC") for the off-sale or on-sale of alcohol has been issued and is current.
- C. If upon application for a business license that contains the off-sale or on-sale of alcohol at a business establishment, and no such licenses are available based upon the provisions of this section, the applicant shall be placed on a waiting list for such a license, where the order of priority is based upon the date of the application is deemed complete by the City. Upon the availability of a license, the applicant at the top of the waiting list shall be contacted by the City to determine whether that applicant still desires to obtain a license. If this applicant no longer desires to obtain a license or is not able to be contacted by the City, then the next applicant in order on the waiting list shall be contacted.

- D. In all calculations of allowable outlets per inhabitants in this chapter, the number of inhabitants shall be that number counted within the City limits in the last federal decennial census, not adjusted or mid-decade figures.
- E. In all calculations of allowable outlets per inhabitants in this chapter, a major fraction thereof shall not allow or provoke an additional permit or license.
- F. No business license shall be issued for the retail sale of off-sale beer and wine (ABC Type 20) if the total number of licensed locations selling exceeds one location per one thousand inhabitants.
- G. No business license shall be issued for the retail sale of off-sale of beer, wine, and distilled spirits (ABC Type 21) if the total number of licensed locations exceeds one location per one thousand inhabitants.
- H. No business license shall be issued for the sale of on-sale beer and wine at a restaurant (ABC Type 41) if the total number of licensed meets or exceeds one location per one thousand inhabitants.
- I. No business license shall be issued for the sale of on-sale beer, wine, and distilled spirits at restaurant (ABC Type 47) or a bar or night club (ABC Type 48) if the total number of licensed locations meets or exceeds one location per two thousand inhabitants.
- J. No business license shall be issued for the sale of on-sale beer, wine, and distilled spirits at a bona fide eating place with a limited amount of brewing of beer (ABC Type 75) if the total number of licensed locations meets or exceeds one location per five thousand inhabitants.

- K. The change in ownership, title, or an ABC license renewal shall be cause to require a new business license application for the off-sale or on-sale of alcohol.
- L. For any business establishment holding a business license that contains the off-sale or on-sale of alcohol, the entitlement to maintain such a license is contingent upon the active status of that business establishment. Upon actual notice by the City that the holder of such a license no longer has an active business establishment connected to that license, the City Council, at a public hearing and with notice to the license holder, may revoke the license upon a finding that the license is no longer connected to an active business establishment.

SECTION 4. VALIDITY OF ORDINANCE

If any article, section, sub-section, sentence, clause, or phrase of this Ordinance is held by a court of competent jurisdiction to be invalid, such decision shall not affect the remaining portions this Ordinance.

SECTION 5. SUMMARY OF ORDINANCE

The City Clerk is hereby directed to cause a summary of this Ordinance to be published by one insertion in a newspaper of general circulation in the County at least five (5) days prior to adoption and again fifteen (15) days after its adoption. If a summary of the Ordinance is published, then the City Clerk shall cause a certified copy of the full text of the proposed Ordinance to be posted in the office of the City Clerk at least five (5) days prior to the City Council meeting at which the Ordinance is adopted, and again after the meeting at which the Ordinance is adopted. The summary shall be approved by the City Attorney.

AN ORDINANCE OF THE CITY OF DOS PALOS ADOPTING BY REFERENCE, THE CALIFORNIA CODE OF REGULATIONS TITLE 24, 2022 EDITION OF THE CALIFORNIA BUILDING STANDARDS CODE INCLUDING THE FOLLOWING PARTS:

And amending those portions of the California Code of Regulations Title 24 as identified herein:

The City Council of the City of Dos Palos does ordain as follows:

Section 1: Purpose and Authority: The purpose of this Ordinance is to adopt by reference the 2022 edition of the California Building Standards, Title 24 of the California Code of Regulations subject to the definitions, clarifications, and the amendments set forth in this Ordinance. The purpose of this Ordinance is also to provide minimum requirements and standards for the protection of the public safety, health, property, and welfare of the City of Dos Palos. This Ordinance is adopted under the authority of Government Code Subsection 50022.2 and Health and Safety Code Section 18941.5.

- <u>Section 2: Conflicts with other laws, rules, etc:</u> In the event of any conflict between this Code and any law, rule, or regulation of the State of California, that requirement which establishes the higher standard of safety shall govern. Failure to comply with such standard of safety shall be a violation of this Code.
- <u>Section 3: Adoption of International, Uniform, and National Codes:</u> The following publications are hereby adopted by reference and incorporated in the Code, except as expressly amended or superseded by the provisions of this Chapter:
- A) <u>California Administrative Code</u>, 2022 <u>Edition</u>, as published by the International Code Council for the Building Standards Commission are adopted by reference.
- B) <u>California Building Code</u>, 2022 <u>Edition</u>, Volumes 1 and 2, including <u>Scope and Administration</u>, based on the 2021 International Building Code as published by the International Code Council (ICC) as adopted and amended by the California Building Standards Commission in the California Building Standards Code, Title 24 of the California Code of Regulations, together with Appendices Chapter G, Flood-Resistant Construction; Chapter H, Signs; Chapter I, Patio Covers; Chapter J, Grading; Chapter K, Central Valley Flood Protection Plan; and Chapter P, Emergency Housing.

C) California Residential Building Code, 2022 Edition, including Scope and Administration,

Based on the 2021 International Residential Building Code as published by The International Code Council as adopted and amended by the California Building Standards Commission in the California Building Standards Code, Title 24 of the California Code of Regulations including all Appendices with the exception of Appendix AL, Permit Fees.

- D) <u>California Electrical Code</u>, <u>2022 Edition</u>, based on the 2020 National Electrical Code and amended by the California Building Standards Commission are adopted by reference.
- E) <u>California Mechanical Code, 2022 Edition</u>, based on the 2021 Uniform Mechanical Code and as amended by the California Building Standards Commission in the California Building Standards Code, Title 24 of the California Code of Regulations.
- F) <u>California Plumbing Code</u>, <u>2022 Edition</u>, based on the 2021 Uniform Plumbing Code and as amended by the California Building Standards Commission in the California Building Standards Code, Title 24 of the California Code of Regulations.

- G) <u>California Energy Code</u>, <u>2022 Edition</u>, as published by the International Code Council as adopted and amended by the California Building Standards Commission in the California Building Standards Code, Title 24 of the California Code of Regulations.
- H) <u>California Historical Code, 2022 Edition</u>, as published by the International Code Council as adopted and amended by the California Building Standards Commission in the California Building Standards Code, Title 24 of the California Code of Regulations.
- I) <u>California Fire Code</u>, <u>2022 Edition</u>, including appendix, based on the 2021 International Fire Code as published by the International Code Council as adopted and amended by the California Building Standards Commission in the California Building Standards Code, Title 24 of the California Code of Regulations.
- J) <u>California Green Standards Code, 2022 Edition,</u> as published by the International Code Council as adopted and amended by the California Building Standards Commission in the California Building Standards Code, Title 24 of the California Code of Regulations.
- K) <u>California Existing Building Code</u>, 2022 Edition, as published by the International Code Council as adopted and amended by the California Building Standards Commission in the California Standards Code, Title 24 of the California Code of Regulations.
- L) <u>California Reference Standards Code</u>, <u>2022 Edition</u>, as published by the International Code Council as adopted and amended by the California Building Standards Commission in the California Building Standards Code, Title 24 of the California Code of Regulations.

<u>Section 4: Liability:</u> The provisions of this Code shall not be construed as imposing upon the City of Dos Palos any liability or responsibility for damage to persons or property resulting from defective work, nor shall the City of Dos Palos, or any official, employee or agent thereof, be held as assuming any such liability or responsibility by reason of the review or inspection authorized by the provisions of this Code of any permits or certificates issued under this Code.

Section 5: Effective Date and Publication: This Ordinance shall take affect on January 1, 2023 after its adoption and published in summary format five (5) days prior to adoption and within fifteen (15) days after its adoption in a newspaper of general circulation published and circulated in the City of Dos Palos. The summary shall be approved by the City Attorney.

MEMORANDUM OF UNDERSTANDING Between

County of Merced, on behalf of its Fire Department and City of Dos Palos, on behalf of its Fire Department

Joint Self-Contained Breathing Apparatus Purchase Through the FEMA Assistance to Firefighters Grant

INTERAGENCY PARTICIPATION PROCESS

THIS MEMORANDUM OF UNDERSTANDING ("MOU") is made and entered into by and between the County of Merced ("Merced County") and the City of Dos Palos for the purposes set forth below.

WHEREAS, Merced County and the City of Dos Palos are committed to working together in providing high-quality emergency services.

WHEREAS, Merced County shall be the "Lead Agency" for the purpose of applying for an Assistance to Firefighters Grant (AFG) and managing the funds for purchasing Self-Contained Breathing Apparatus (SCBA) and associated supportive equipment for the agencies involved. The City of Dos Palos shall be the "Partner Agency."

WHEREAS, Merced County will provide the funding for the required ten percent (10%) matching cost for the equipment to be purchased using grant funds that may be awarded.

WHEREAS, the City of Dos Palos desires to acquire and place SCBA Equipment on its emergency response vehicles for use by their First Responder personnel; and

WHEREAS, the application prepared and approved by Merced County and the City of Dos Palos is to be submitted to the Federal Emergency Management Agency (FEMA).

OBJECTIVE OF AGREEMENT

The primary objective of this MOU is to establish a purchasing group for the purpose of replacing SCBAs which are at the end of their service life. The group will also be purchasing additional masks. See the table below for specific allocations of equipment.

By forming this purchasing group critical benefits will be achieved; improved interoperability, increased purchasing power which will lower the unit pricing, better

customer support from the manufacturer, and a thorough evaluation of the units in the marketplace. Most importantly, a long-term benefit will be the support each agency will be able to provide to the partner agency in servicing units and reducing duplication.

OBJECTIVE OF REGIONAL AFG SCBA PURCHASE

The primary objective of the Regional AFG SCBA purchase is to increase the Central Valley's regional interoperability and to enhance the local capabilities of each community therefore enhancing national capabilities.

RESPONSIBILITIES OF THE PARTIES

The Lead Agency agrees to apply for the AFG, to manage the funds from the grant award, ensure that a competitive and fair purchasing process is followed, and to initiate the purchase with the vendor.

The Lead Agency agrees to:

- Provide funding for ten percent (10%) (agency match) of the matching cost for equipment to be purchased
- · Oversee the grant implementation and coordinate with the grantor
- Act as the fiscal agent for the grant by:
 - o Invoicing the Partner Agency for payment of its cost share of equipment
 - Arranging payment to vendor
 - o Preparing and submitting fiscal and program reports to grantor
 - Auditing and tracking grant funds and deliverables
- Manage grant activities, including but not limited to, project and fiscal reports for grantor
- Coordinate with the Partner Agency throughout the grant term
- After receiving input from the Partner Agency, make the final determination of the SCBA equipment to be ordered
- Coordinate procurement of the SCBA equipment and make final procurement decisions
- Procure the SCBA equipment in compliance with local and Federal procurement policies and requirements
- Deliver the SCBA equipment to the Partner Agency subject to execution by both parties of an Agreement that governs the ownership and use of the equipment purchased with the funds that may be awarded under the AFG application
- Maintain documentation of any changes to the award and/or distribution, compared to the original application
- Ensure payment and compliance of all partners included in the grant
- Ensure that all activities comply with the terms of the Notice of Funding Opportunity (NOFO), Award, federal regulations, laws, and Executive Orders as applicable

The Partner Agency agrees to:

- The Partner Agency will provide the following assigned liaison(s):
 - o Project Lead: Primary point of contact responsible for SCBA equipment

- Promptly provide any additional documentation to Lead Agency as requested which may be necessary in connection with the AFG
- Ensure all documents demonstrating programmatic completion are completed in a timely manner, are accurate, and forwarded to the designated Lead Agency contact
- Maintain all SCBA equipment and grant records, files, and supporting documentation in the event of an audit for three years after the official closeout
- Ensure that all activities comply with the terms of the host/lead agency, Notice of Funding Opportunity (NOFO), Award, federal regulations, laws, and Executive Orders as applicable
- Collaberate with Lead Agency on an Agreement that governs the ownership and use of the equipment purchased with the funds that may be awarded under the AFG application

DURATION OF MOU

The MOU will be in effect from the latest date of signing stated with the Parties' signatures until either of the agencies receive notification that the grant was not successful, or the grant is received, and the units have been distributed to each agency. It is expected that all work can, and will, be completed within one (1) year of the grant award.

TERMINATION

This MOU will be difficult to terminate once the grant has been accepted. Due consideration shall be taken prior to signing the MOU. If an agency wishes to terminate prior to accepting the grant, then the grant could be modified for that agency to be removed. However, after the grant has been accepted it will be difficult and would be dependent on the restrictions and processes set forth and enforced by FEMA. If an agency wishes to withdraw from the MOU, then written notification must be given to all agencies immediately for consideration due to timing constraints.

AMENDMENTS

This MOU may be amended at any time by written agreement of all agencies. Such requests will only be approved if the proposed change(s) is/are consistent with and/or achieve the goals.

HOLD HARMLESS AND INDEMNIFICATION

Each party to this Agreement shall protect, indemnify, and hold harmless every other party and their officers, agents, and employees from and against any and all claims, costs, and/or issues whatsoever arising from actions by such party and/or its subcontractors pursuant to this MOU. Each party shall defend at its own expense and all claims, demands, suits, penalties, losses, damages, or costs of any kind whatsoever (hereinafter "claims") brought forth and arising out of or incident to such party's execution of, performance of failure to perform this MOU.

SEVERABILITY

If any section, subsection, sentence, clause, or phrase of this Agreement is, for any reason, found to be unconstitutional or otherwise invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions.

Any notice required or permitted under this Agreement shall be deemed sufficiently given or served if sent to the party at the addresses provided:

For all types of mail, the postmarked affixed by the United States Postal Service shall be conclusive evidence of the date of mailing.

ENTIRE AGREEMENT

This MOU constitutes the entire Agreement between the parties. There are no terms, obligations, covenants, or conditions other than those contained herein. No modifications or amendments of this MOU shall be valid or effective unless evidenced by an agreement in writing signed by all parties.

COMPLIANCE WITH REGULATIONS AND LAWS

The parties shall comply with all applicable laws, rules, and regulations pertaining to them in connection with the matters covered herein. This MOU shall be deemed to be made and construed in accordance with the laws of the State of California. Jurisdiction and venue for any action arising out of this MOU shall be in Merced County, California.

City Project Status

The following will provide a brief report on the status of various projects and items being addressed by QK staff or working with City Staff to provide assistance of the last month.

Water Plant replacement project:

Construction Documents – The documents are still being reviewed by the State Water Staff in Fresno office at the time of writing this memo.

Project schedule:

Once the State provides the Notice for the City to Proceed with gong to bid on the project, I will provide a schedule for the Bidding phase, Contract award phase and the start of Construction.

I prefer to not again provide a potential schedule to you and be waiting on another agency for their response, I apologize.

The timelines of days for bidding the project and going through the award process would remain the same, once we get the approval to move forward.

Screen at Aqueduct:

The screen installation is overseen by three agencies: Bureau of Reclamation Department of Water Resources (DWR) – CA San Luis Water District (SLWD)

The Bureau of Reclamation has the authority for the construction in the channel DWR has the authority over the schedule when the work is to be completed SLWD – authority to allow the installation within their District Boundary

The original project that installed the out take from the aqueduct for the siphon was also completed with the assistance of CCID.

We had a call with the Bureau and DWR staff on their process to make modifications to the existing out take (siphon).

There is a package to provide and we are putting all of the requested information together for the submittal. This includes the plans for the new out take and screen assembly, equipment information, environmental documents, plans for the existing siphon, flow requirements and use of power or solar at the site. The meter that measures the flow for billing will also be replaced as it is older and could not be providing accurate readings, as per the request of the Bureau. We are

working through the existing permit issue and if not found they will issue a new permit for the out take ability to pull water from the Aqueduct.

Rate Study: No Change

The report will be update with the comments from the State Board staff on the Construction Documents to reflect the current cost for the project to establish the proposed rates. Then update rates will be presented for review at a future meeting based on the new estimated project cost. The proposed schedule will be adapted to meet the time available between bid opening and start of construction. -

Valeria Street Project – The environmental document prepared by BSK was delivered to Caltrans, they reviewed and accepted the document. In their response, Caltrans has asked for a Hazardous Materials memo to be completed as well, so QK staff is compiling the information to complete the document. Additionally, QK staff is completing the documents to pull the project off the inactive list; this includes submitting an invoice document that has a proposed timeline for the project completion and budget figures for different tasks.

Thomas Street Project – The project received two bidders, the City Manager has provided the breakdown for the two bids and the recommendation is to award the Base Bid to the lowest Bidder.

Center Street – Warranty Work – The Contractor is going to do the work the week of October 24th and it will be a two day process for the repairs and slurry seal placement

Wastewater – Craig finalized which equipment to purchase for the replacement of the bar screen at the WWTP.

Dora Street Lift Station, Reviewed the plans with Craig and making updates based on his comments, electrical engineer is developing water level control system for pumps and future SCADA controls space in electrical panel.

Drought Planning - No Change

Senate Bill No. 552 – this bill will require water providers serving between 1,000 and 2,999 connections to develop a Water Shortage Contingency Plan, those systems serving less 1,000 connections will also be required to develop an emergency notification and response plan, this will need to be completed by July 1, 2023.

Other items: The State has requested an update to the Sanitary sewer Management Plan, I am working with Craig to provide an update to the report we prepared about ten (10) years back. I worked with legal counsel to prepare a response letter to the Water Board on the water availability through the agreement with the Bureau and JPA.

Any changes or update will be provided at the meeting.
