#### Dos Palos City Council Minutes March 15, 2022

- **A.** CALL TO ORDER: Mayor pro Tem Debbie Orlando called a regular meeting of the Dos Palos City Council to order at 6:00 pm in the City-County Building at 1546-1554 Golden Gate Avenue in Dos Palos, California on Tuesday, March 15, 2022.
- 1. The **Pledge of Allegiance** was led by Councilmember Marcus Porter.
- 2. An Invocation was led by Councilmember Thomas Pigg.
- 3. Roll Call: City Clerk Ysidro Garcia Called the Roll finding four of the five City Councilmembers present: Mayor pro Tem Debbie Orlando, Councilmember Thomas Pigg, Councilmember Armando Bravo, and Councilmember Marcus Porter. Mayor April Hogue was absent due to illness.

Others present included: City Attorney Edward Amaral, Jeanette Baker, Claudia Bretado Bautista, her mother, Public Works Director Gordon Bonds, former Mayor Michael Burns, Nicole Burns, Reserve Officer Stephen Choi, Richard Dechaney, City Manager/CEO/PC Darrell Fonseca, City Clerk Ysidro Garcia, Director of Utilities Craig Hackett, Miranda Lopez, Chief of Police Rich McEachin, DPOLJUSD Trustee Moy Meraz, Lynn Miles, Randy Miles, Janet Miller, Katy Miller, Scott Miller, Tracy Mosby, City Engineer Garth Pecchenino, Maria Pina, Kathy Simmons, and Director of Finance & Personnel Manuela Sousa.

- 4. Urgency Additions or Deletions: None.
- 5. **Public Forum:** Randy Miles asked about the new state mandated food waste recycling plan.

#### **B. CONSENT CALENDAR:**

- 1. It was moved by Councilmember Porter and seconded by Councilmember Pigg to approve the **Minutes** of the regular meeting held on February 15, 2022. The motion passed 4-0-1 as follows: AYES: Orlando, Pigg, Bravo, and Porter. NOES: None. ABSTENTIONS: None. ABSENT: Hogue.
- 2. It was moved by Councilmember Porter and seconded by Councilmember Pigg to approve the **Pre-Paids** for February 2022. The motion passed 4-0-1 as follows: AYES: Orlando, Pigg, Bravo, and Porter. NOES: None. ABSTENTIONS: None. ABSENT: Hogue.
- 3. It was moved by Councilmember Porter and seconded by Councilmember Pigg to approve the **Warrants** for March 2022. The motion passed 4-0-1 as follows: AYES: Orlando, Pigg, Bravo, and Porter. NOES: None. ABSTENTIONS: None. ABSENT: Hogue.

#### D. UNFINISHED BUSINESS:

- 1. Following a staff report, Mayor pro Tem Orlando reminded the council that most of the legal representations for litigation, liability, or workers comp, are handled through the risk management authority, not by the city attorney. Scott Miller asked the city manager if he is satisfied with current legal counsel's advice to the council. City Manager Fonseca responded "For the limited responsibilities of general Brown Act interpretation, dealing with contracts and agreements, lower cost, and especially for quick responses and access, yes." The council gave direction to staff to arrange in-person-meetings with Legal Counsel RFP applicants and councilmembers. The city attorney advised that no more than two councilmembers meet unless a public meeting is held.
- 2. It was moved by Councilmember Porter and seconded by Councilmember Bravo to Authorize staff to conduct a **Fireworks** Sales Permit Lottery after the 12 noon, Wednesday, March 30, 2022 deadline. The motion passed 4-0-1 as follows: AYES: Orlando, Pigg, Bravo, and Porter. NOES: None. ABSTENTIONS: None. ABSENT: Hogue.

#### D. NEW BUSINESS:

1. At his last city council meeting, City Manager Darrell Fonseca presented his final staff report which included information about the City's Seal, Official Flag and Colors, Mission Statement, Officeholder Visits to Dos Palos, Office Holder History lists of Merced County Supervisors who have represented Dos Palos since its founding, Mayors, CEO's, City Clerks, Chiefs of Police, Police Commissioners, City Attorneys, City Engineers, and City Treasurers, City Assignments, City Debt. a 2021-2022 Balanced Budget Summary, Privatized Contractors, Franchisees, and Suppliers, a Measure V Priority List, a six year Water Usage Report, a Diversity Summary, Largest (Top 35) Employers in the City of Dos Palos, Stocks of Local Interest, Liquor License Allowed, Unemployment Rates for the last 13 years, Crime Stoppers Agency and Crime Tip Reports, information about the Dos Palos Theatre, the most recent Covid Virus Update, and the Organizational Structure of the City, attached as an exhibit at the end of these official minutes. Fonseca reported that new bus shelters will soon be installed across the street at Dos Palos Downtown Station, in Midway in front of the Carver Center, and eventually on Loraine Street near the Del Hale Hall in O'Banion Park. He reported that he will continue to work on bringing a major fast -food franchise to Dos Palos, that Family Dollar will begin a transition to Dollar Tree. At this point City Manager noticed former Mayor Michael Burns in the audience and thanked him for his leadership and contributions to our city saying, "Those were good years and we accomplished a lot!"

Fonseca reported that Congressman Jim Costa called to report that President Biden signed the infrastructure bill which included his application for Community Projects funding in the amount of \$279,000 from the Department of the Interior to repair the

Water Clarifier and Splitter Box at the water plant. Fonseca reported that work is underway on the \$1,600,000 construction of the 750,000 gallon water tank funded by the Federal American Rescue Act.

He said he had a special parting gift for the city council and was disappointed that the mayor was not able to attend this meeting. City Manager Fonseca announced that through the significant help of City Engineer Garth Pecchenino and Assemblymember Adam Gray, now a candidate for Congress, and city staff, the Department of Water Resources has determined that due to increased labor and materials costs, acknowledgement that reduced flows in the California Aqueduct have also contributed to increasing levels of algae, which have adversely impacted the City's treatment capabilities, and a request from the City of Dos Palos for additional funding, the City of Dos Palos will now be eligible for a 100% Grant of \$30 million towards the new water treatment plant and aqueduct intake facility. A standing ovation from the audience occurred at this time.

- 2. A Proclamation honoring City Manager Darrell Fonseca for his 32 years of service was read. It mentioned that City Manager Fonseca is currently the State of California's longest serving city manager in a single city. Mayor pro Tem Orlando presented a city plaque to Fonseca and read a certificate from the Merced County Board of Supervisors. The audience applauded in standing ovation. Councilmember Pigg said "The city, our community, was the better for having you as our city manager, Darrell, a job well done!" Councilmember Porter commended City Manager Fonseca for his service. Councilmember Bravo and Public Works Director Bonds each thanked Fonseca for hiring them earlier in their careers.
- 3. City Manager Fonseca asked that all members of his **Staff** please stand. He then said, "These are people that made my years successful. Thank you all for your help!"
- E. CORRESPONDENCE, EVENTS, & REPORTS: Various reports were presented.
- F. EXECUTIVE (CLOSED) SESSION: None.








California has 482 cities, including the City and County of San Francisco.

Governance - City councils serve as the legislative branch of city government by creating laws, adopting ordinances and resolutions. Most city councils have five or seven elected members. The city council is led by a mayor, however, the duties of the mayor vary. Under a council-manager government (also known as weak or ceremonial mayor system), the mayor serves as an equal with the city council members and executive functions of the city are performed by a city manager. Under a mayor-council government (also known as a strong mayor system), the mayor has significantly more authority and may be responsible for more administrative and management duties. Cities can elect other city officers, such as an auditor or attorney.

**Powers –** Cities that rely on state law for their powers and responsibilities are called **general law cities**. Many use the council-manager form of government. The California Constitution lets **charter cities** govern their own municipal affairs under locally adopted charters that control their powers and structures. Several use the strong mayor form of government. There are 361 general law cities and 121 charter cities.

**Services -** Whether living in general law or charter cities, city residents receive a variety of municipal services including police, fire, libraries, parks & recreation, roads, public transit, street trees, lighting & landscaping, water, sewers, and planning & development.

• Full service cities provide these services themselves.

• Partial service and contract cities rely on special districts and counties to provide many of these services to their residents.

City and County Relationship - A city governs and provides services for residents only within their city limits. Every city lies within a county. Counties provide countywide services (jails, probation, district attorney, assessor, elections, clerk, recorder, and animal control) and state mandated social and health services to all city residents within their county. Some counties have many cities within their boundaries and other counties have no incorporated cities. San Francisco is California's only consolidated city and county.



#### POLITICAL & CAMPAIGN SIGN ORDINANCE

Dos Palos Municipal Code 17.64.070 Outdoor Advertising, F. Political or Campaign Signs, Adopted 1997.

- 1. Political or campaign signs shall be allowed in all districts and zones.
- 2. Political or campaign signs are any form of advertising of any size, including posters, bearing any of the following: a cause, issue, or candidate's name, an election date, the word "yes" or "no," etc.
- 3. Political or campaign signs shall not exceed thirty-two square feet in area and shall be no longer than eight feet in length.
- 4. Political or campaign signs shall be placed entirely upon private property with permission of the property owner.
- 5. Political or campaign signs shall not be placed earlier than sixty days prior to the election day for which the issue is being decided or of which the candidate is seeking election.
- 6. All political or campaign signs, including thank you signs, shall be removed within one week following the pertinent election.
- 7. One week after the election has passed, any remaining political or campaign sign may be removed by the city and the cost of such removal and disposal shall be charged to the pertinent candidate or campaign committee.
- 8. No vehicle or trailer containing a *non-complying* political or campaign sign shall be allowed to park on any city street.

#### City Debt

**No New Debt!** Previous city council members ran the city into a lot of debt. Inheriting nearly \$28 million of City Debt, City Manager Fonseca made it the City's policy to pay down existing debt, refinance existing debt if favorable, and avoid borrowing any money except in an emergency. Borrowing creates new debt and you end up paying a lot more. Every effort was made to obtain grants and reduce spending. Grants frequently made up 10% to 33% of the City's annual budgets. Councilmembers should be skeptical of placing the burden of new debt on future generations. Every effort should be made to pay off the city's wastewater loan early if possible, once it drops below \$1 million, to free up that debt service portion of the city's monthly utility bill, and to avoid increasing future rates. Fonseca's efforts have paid down nearly \$25 million of the City's \$28 million dollars in debt, that's a pay off of nearly 88%!

- 2. <u>Center Avenue North:</u> (Center Avenue from O'Banion Park to Colony Park and Loraine Street), a portion of Marguerite Street at Center Avenue was added during construction. *Completed*
- Blossom Street East: (includes East Blossom Street and connections from 3. Lucerne Avenue to Palm Avenue). Scheduled for 2022-2026. East Blossom qualifies as an Arterial or Collector and is eligible for additional funding. Funding committed and secured thus far includes \$1,004,812 in local Measure street funds. and \$158,355 in local Measure Alternative/Sidewalk funds; \$1,588,000 from Westside Regional funds previously programmed in 2019, and \$2,387,000 that staff programmed on October 21, 2021 which was approved by the Westside Regional Committee on October 28, 2021, and MCAG on December 16, 2021; \$783,039 in Rule 20A undergrounding funds; and \$96,000 in anticipated local Measure V street and sidewalk funds to be received in 2022 for a total of \$6,017,206 now available for the Blossom Street East Project. These totals do not yet include local water, sewer, or storm drainage underground replacement funds, or any possible DPOLJUSD partner contributions.
- 4. <u>Center Avenue South near Marks School</u> (between Valeria Street and the Southern City Limits).
- 5. <u>Frank Avenue East near Dos Palos Elementary School</u> (between Almond Street and Valeria Street).
- 6. Remaining <u>Downtown and Other Sidewalks Citywide</u>.
- 7. <u>Almond Avenue near the Cemetery</u> (starting at Elgin Avenue/Highway 33 and working West toward General Avenue).
- 8. <u>Virginia Avenue</u> (between Palo Alto Street and Valeria Street).
- 9. Marks Subdivision (includes Mumby Ave., Geis St, Johnson Ave., Jones St).
- 10. <u>Marguerite Street</u> (Marguerite Street from Carol Avenue to Frank Avenue and Carol Avenue from Marguerite Street to Blossom Street).

The referendum requires that these street and sidewalk priority projects be completed first. After completion, the council may use Measure V funds for other locations.

#### HISTORIC DOS PALOS THEATRE

2021 Request: \$300,000 to purchase and restore the Dos Palos Theatre with ADA upgrades.

Description: The Dos Palos Theatre, located in the downtown area, opened on Christmas Day in 1946. The first movie shown here was "It's a Wonderful Life." It is a valuable community resource that must be preserved. This historic Theatre, to use the old spelling on its marquee, has served local residents for generations as a movie theatre. It's stage has hosted live theatre for local drama clubs and school plays. The auditoreum was used as a community hall for candidate's debates and other important forums. Many live musical performances and educational lectures have been held here. The building's structural integrity is good but its façade is deteriorating, it's marquee is sagging, and its roof needs replacing. This two story theatre with a balcony, seats 350 people. Built by the city's first mayor, it served nearby military cadets in the 1940's. It was a woman owned and operated business for several decades at a time when that was rare—the 1950's and 1960's. The Dos Palos Theatre set all time attendance records that still stand when it was the only theatre in a 100 mile radius to show The Beatles first movie— A Hard Day's Night while other theaters shunned the group and their film. The Theatre's Lobby features unique artwork including the images of various actors that seem to move their eyes and morph into different characters as you move about the room.

**Necessity:** The building needs to upgraded to meet current Americans with Disabilities Act standards. The Theatre's original heating, cooling, lighting, and plumbing all need to be modernized. Our small town needs a multi-purpose community center. This facility would fill that need. It was proposed that a local non-profit group be formed to support the cause of restoration once initial seed money is secured.

**Beneficiaries:** All ages, young and old could benefit from a restored community theater. A renovated theater could also become a venue for various ethnic groups to promote and display their culture and diversity, and by adults and school children in the performing arts.

Status: This proposal was tabled at the March 2021 city council meeting.
